before the Supreme Court?

Madam Speaker,

I am informed by the Master and Registrar that the statistics requested are as follows:

Civil cases pending over 10 years before the Supreme Court: **412**

Criminal cases pending over 10 years before the Supreme Court: **Nil**

ADDITIONAL INFORMATION PROVIDED BY MASTER AND REGISTRAR

(A)The Supreme Court has unlimited criminal and civil jurisdiction (Section 76 of the Constitution). It has original jurisdiction in all civil suits (Section 15 of the Courts Act) but also acts as an appellate court for all subordinate courts (Section 82 of the Constitution) and tribunals, when so empowered by law.

It is a Court of Equity, has the same powers and functions as the High Court of Justice in England and exercise disciplinary powers in respect of the professional conduct of a law practitioner or a ministerial officer including a land surveyor (sections 16, 17 and 18 of the Courts Act).

The Judges of the Supreme Court also sit "in Chambers" to hear urgent injunctions and applications

Cases, when in shape, are fixed for merits according to an established order of priority as follows:

- I. Constitutional redress
- II. Criminal cases
- III. Criminal Appeals
- IV. Civil Appeals
- V. Judicial Reviews
- VI. Accidents at work
- VII. Road accidents

It follows that civil cases other than the above will have to take their turn on the list and fixed for merits as and when a slot is available.

The Judicial and Legal Service Commission will soon proceed with the appointment of a new Puisne Judge. We have the same infrastructural problems at the Supreme Court especially in the two wings of the historical building. In September 2014 one Puisne Judge had to occupy an office at the Commercial Division since her appointment although she sits at the Civil Division of the Supreme Court. Further another Puisne Judge had to vacate his office because of water leakages at the left wing and one Court room had to be closed for the same reason.

The Honourable Chief Justice would therefore invite Honourable members of Parliament to make a site visit of the Supreme Court building especially in times of rain.
