**A BILL**

**To provide for the issue from the Consolidated Fund of the sums necessary to meet the expenditure, both recurrent and capital, in respect of the services of Government for the financial year 2020-2021 and for the appropriation of those sums by votes of expenditure**

ENACTED by the Parliament of Mauritius, as follows –

**1. Short title**

This Act may be cited as the Appropriation (2020-2021) Act 2020.

## **2. Appropriation of sums for services of Government**

(1) A total sum not exceeding one hundred forty-four billion and three hundred million rupees (Rs.144,300,000,000) shall be issued from the Consolidated Fund to meet the expenditure, both recurrent and capital, in respect of the services of Government for the financial year 2020-2021.

(2) The expenditure of the total sum under subsection (1) shall be appropriated by votes of expenditure, in conformity with the Schedule to this Act and the Estimates 2020-2021 laid before the Assembly.
